MAB has not yet received an invoice for the Third Age Magazine postal subscription. Clive will follow this up. The budget is available, the figures are until the end of March and the Capitation has been added in. The figures are not reconciled with the Bank or Bookkeeper yet. Following an error by the HSBC bank they are putting £50 into our account. Barbara Connah proposed that MAB approach Nat West regarding changing our account to them. Chris Blacket seconded and all present agreed.
- 7. <u>Secretary's Report.</u> Nothing to report.
- **8.** <u>Membership Secretary's Report.</u> We have a membership of 385. 9 members have not paid for the U3A magazine.
- **9. Group Co-ordinator's Report.** Last month 13 people became temporary members and 2 joined.
